Re. My SEC Complaint v Buffett, "et al", and my related FTC Complaint v Lubrizol can help President Trump and Republican Senators launch a counter offensive to the continuing attacks against President Trump and certain Republican Senators. Despite the Impeachment trial acquittal reported in the news, It is apparent the attacks will continue.

Dear Senator Lee,

My purpose in reaching out to you is to provide you with another copy of my February 6, 2021 letter and SEC/FTC Complaint documents that you reportably received by Fed Ex at your Russell Senate Office Building address at 10:22 am on Friday, February 12, 2021, and signed for by W. Groove.(See enclosed Fed Ex tracking). I have reason to suspect the SEC and FTC Complaint documents may have been removed from the package.

Also enclosed again in this package is a February 4, 2021 letter to President Trump c/o Mike Lindell, and my SEC Complaint related documents.

This package also contains another copy of the Summary Brief, dated November 6, 2018 for my FTC Complaint against the Berkshire Hathaway subsidiary, the Lubrizol Corporation. As you are Minority Leader of the Senate Judiciary Sub-Committee for oversight of the FTC, I believed this would be of interest to you.

The Summary Brief contains a money damages report on lost net income to Polar Molecular Holding Corporation caused by Lubrizol, entitled "Assessment of Earnings Opportunities". The lost net income reported is currently about \$40 billion with a contingent liability of around \$120 billion plus legal fees if a civil Rico or antitrust claim is upheld in federal court.

Another document in this package is a folder of literature and research reports on our proprietary, environmental Duralt Fuel Additive Technology that reduces green house gas emissions, and other harmful emissions at a net savings to motorists and society.

I would very much like to discuss all of this with you, and would appreciate it if you would pass this information on to President Trump and his legal counsel.

My earlier package to you was supposed to be sent by Fed Ex in Lansing, Michigan (tracking enclosed) on Wednesday February 10, 2021 and was supposed to arrive by 8:30 am on Thursday February 11, 2021. However it was received at 10:22 am Friday 12, 2021. I have reason to believe that the November 6, 2018 FTC Complaint Summary Brief, my SEC Complaint documents and possibly the Duralt literature folder (enclosed again) were removed from your package late Wednesday February 10th. Then the package was forwarded to you on Thursday February 11th and received on Friday February 12th at 10:22 am. (See enclosed Fed Ex tracking information).

Please let me, and Senator Lindsey Graham know if you received my FTC v Lubrizol Complaint, my SEC Complaint documents, and Duralt information folder in the package you received on 10:22 am on Friday February 12th, and signed for by W. Grove.
