Dear Senator Graham,

Congratulations on your re-election to the United States Senate representing the great State of South Carolina, and your leadership in getting Judge Amy Barrett confirmed to the Supreme Court. President Trump's nomination of Judge Barret and the Senate confirmation of Judge Barrett to the Supreme Court is more than a political victory, it was a essential step in protecting our Republic from the leftist agenda of the Democratic Party, the "mainstream" fake news media and a handful of would be "oligarch" billionaires including Buffett and Gates.

Another vital accomplishment this year is thus far maintaining the Republican Senate majority as a fire wall against the leftist agenda of the above coalition. The President's support for that effort with his tireless campaign effort around the country was vital as you recently noted in a Fox interview. Despite unprecedented spending by the opposition it now appears that the Republican Senate majority will hold.

Meanwhile all eyes are on Georgia and the two Senate seats subject to the January run off. Once again the above leftist coalition will spend unprecedented sums of money and will have the full support of the "mainstream" fake news media as it's PR department. As the lyrics of a popular Charlie Daniels song once proclaimed, "the Devil came down to Georgia looking for a soul to steal". In this case it is the soul of the American Republic that the devilish left coalition is attempting to steal. The President is seeking a recount in Georgia and you are contributing \$1 million to the two Republican Senators in the Georgia run off. If one Republican prevails the Republican Party maintains control of the Senate. In the House, Republicans have a net gain of seats in defiance of the polls and despite record spending by Democrats. This reduces the chance of the leftist agenda succeeding in the House, and moderate Democrats are blaming the losses on the 'progressive' agenda.

The President is fighting to protect free and fair elections, is contesting some alleged outcomes in favor of Biden.

The Presidency would not be in contention today, and the President would have sailed to a certain victory but for the following:

- 1). The frivolous, partisan impeachment that the Democrats knew would fail in the Senate was simply intended to undermine the President's credibility with swing voters.
- 2). The Chinese Communist Party virus was launched against America with the President as the primary target. The leftist Democrats and the fake news media used the Chinese virus as a excuse to shut down the country and undermine the U.S. economy, the President's signature achievement, and justify massive mail in voting benefiting Democrat candidates.
- 3). In addition, 250,000 American lives were sacrificed, and the Democrats and news media blamed the President for what they and their Chinese Communist Party co-conspirators did. The ultimate objective was to undermine the support for the President with swing voters, and greatly increase Democratic voter turnout through mail in ballots due to the pandemic.
- 4). The Democrats and the "fake News" Media ignored Joe Biden's complicity in his son Hunter Biden's business deals in China and elsewhere, and refused to question Biden.
- 5). The Democrats and news media promoted the "Russia conspiracy" against the President and even after it was disproven the media and Democrats continued the scam.
- 6). President Trump's successes including peace in the Middle East and his nominations for the Nobel Peace prize were largely ignored.
- 7). Operation Warp Speed was the driving force for development by Pfizer of a virus vaccine in record time, and now even the FOX headline reads, "Trump and Biden Celebrate Vaccine."

Despite all of this, the spending of unprecedented sums of money in the elections by the leftist establishment, and the endless anti-Trump drumbeat of the media blaming him for what they did, the election results are razor thin in the battleground states, and across the country.

This is a follow up to my letter to you dated October 16, 2020 (enclosed), and the package of related documents delivered to you at your offices at the Russell Senate Office Building on October 19, 2020 at 9:10 am (UPS Tracking enclosed). I realize that you likely have not seen my letter and package given your enormous commitment of time and energy for the successful Amy Barrett Supreme Court confirmation process, your re-election campaign effort and your current efforts to help the President clean up the irregularities and outright fraud in the 2020 national election.

I also concluded that you are more likely to see my communications to you if delivered to your office for the Senate Judiciary Committee where you likely spend much of your time, out of necessity.

In that October 16<sup>th</sup> letter to you and the enclosed letters to President Trump dated September 30, 2020 and October 2, 2020 I informed you and the President that I was a

“Whistle Blower” for the United States Securities & Exchange Commission (SEC) and now a Whistle Blower for President Trump against Democrat Billionaire Warren Buffett for concealing a well documented claim and liability of \$36 billion in his SEC filings, all of the members of Buffett’s Board of Directors including Bill Gates, and NBC CEO Stephen Burke for failure to correct the omission of \$36 billion in liability, the Democrat Leadership including Nancy Pelosi and Maxine Waters for protecting Buffett from justice, and the “fake news” media including NBC, the AP and Reuters, for a cover up.

I also have letters and documents with Fed Ex tracking related to my SEC Complaint that I sent to other prominent Democrats, including Elizabeth Warren, Bernie Sanders, Congresswoman Alexandria Ocasio-Cortez (“AOC”), Yanna Pressley, and Eric Swallwell. None of them responded or took appropriate oversight action.

This despite the fact that I provided them with a copy of a September 27, 2018 letter to me from Jane Norberg, Chief of the Office of the (SEC) Whistle Blower thanking me for bringing this matter to her attention, opening up a formal “Submission”, asking me to provide any additional information, and that I sign a form TCR to officially become a Whistle Blower for the SEC. I did.

With the October 16, 2020 letter to you and the September 30 and October 2, 2020 letters to the President I enclosed a November 12, 2019 Confidential letter to the President emailed to him on November 13, 2019 announcing my role as a SEC Whistle Blower and now a Whistle Blower for the President against Buffett, “et al” and offered to give him all of my SEC Complaint files in order to help him to launch a “Counter Inquiry” to the “Impeachment Inquiry”.

The offer and Confidential letter to the President was “hacked” by agents of Buffett and a potentially lethal medical retaliation was launched against me when two doctors at the Veterans Administration (VA) hospital in Aurora, Colorado were paid off by a “bag man” working for Buffett and a Buffett subsidiary the Lubrizol Corporation that incurred the undisclosed \$36 billion liability due to it’s theft of our company’s intellectual property and other unlawful acts against our interests.

(I receive medical care at the VA because I am a 50% disabled veteran of the Viet Nam War).

All of this is discussed in detail in the enclosed October 16<sup>th</sup> letter to you and the enclosed September 30<sup>th</sup> and October 2<sup>nd</sup> letters to the President. I have also taken the liberty of enclosing all of the related documents that were delivered to you and President Trump in October. I have also enclosed tracking confirmations.

In October, I also sent similar letters and documents to Senators Cruz, Hawley, Cotton and McSally in attempts to help the President and Republican Senators in the 2020 election effort. Those letters and tracking are enclosed for your edification. Perhaps you could reach out to these other Republican Senators and alert them to my letters and packages sent to them. Given the fact their staffs are working from remote and given the election turmoil, I doubt they have even seen the packages and letters.

I also send letters and the documents to Fox anchors, Sean Hannity, Tucker Carlson and Laura Ingraham in attempts to get through to the President and to Republican Senators including you. I have enclosed those letters to Fox and tracking confirmations for your edification. I'm guessing the Fox anchors did not reach out to the President, you or the other Republican Senators. Meanwhile, of the three Fox anchors I reached out to, only Sean Hannity seems to be supporting the President's legal challenges to the election irregularities and outright fraud.

In fact, subsequent to my packages arriving, Fox called the Election for Biden and Harris despite reports of wide spread voter fraud and irregularities, and the Presidents legal efforts to thoughly investigate them in order to protect the integrity of the election.

On Monday, November 9<sup>th</sup> I saw your interview with Brooke Singman of Fox and I completely agree with all of your points. The media does not decide elections and the President can not concede given the wide spread irregularities and out and out criminal fraud,

In effect, if the President were to concede it would be tantamount to turning the United States government over to a criminal conspiracy. After that there would never again be a chance for fair and honest elections in the United States of America.

The President and the Republican Senate majority, including you Senator are doing the absolute right and essential thing. Given the outright criminal attempt to silence me as a Whistle Blower for the SEC and the President I can attest to that fact with real authority.

I have convincing evidence of this potentially lethal retaliation against me for attempting to assist the President as a Whistle Blower. I also have proof that the retaliation against me is ongoing. I am fully prepared to provide my evidence to you, and to testify before the Senate Judiciary Committee. I will also co-operate fully with the DOJ as well.

God Bless you and the President for what you are doing to correct this enormous problem to our country and to all Americans, whether the "news media" including Fox agrees or not. Unfortunately, at this point it is very obvious that this problem does extend to Fox News who are clearly now on the wrong side of history along with the "main stream" media, or as the President calls it, "fake news".

I believe it is critical that we talk as soon as possible. The retaliation against me is ongoing and potentially lethal. I will come to Washington, D.C. at your earliest convenience for indepth discussions. I also have and will share with you all of my evidentiary files and records, including my SEC Complaint with nine extensions, and my detailed FTC complaint against Buffett's subsidiary the Lubrizol Corporation.

I have enclosed the Summary Brief for the November 6, 2018 FTC Complaint v Luvbrizol Update with Economist Study.

Some of my files and evidence include criminal violations of law by a “agent provocateur” and “bag man” for Buffett, “et al” and Lubrizol. His name is Carl Hill and I believe he bribed the two doctors at the VA Regional Center in Aurora, Colorado to launch the medical retaliation against me. Hill is responsible for a computer and email “hacking” operation to follow my movements. I also have reason to believe Hill is “tracking” all my packages sent by FedEx, UPS, and USPS in order to shadow me closely. He was very successful in doing so in Colorado resulting in my contact with FedEx CEO Fred Smith.

Hill is now active here in Michigan and a follow on retaliation against me with the VA Hospital in Ann Arbor, Michigan, and a cover up appears to be underway. I do not think it would be wise to delay a meeting between us.

I would also like to have a meeting with the DOJ as soon as possible. I know the DOJ can shelter witnesses and evidence. I am also very concerned about the safety of my family and want them protected.

I am certain that President Trump’s list of people he can trust at this point is very short. I think that is very wise. Last year in November I reached out to Senator Mike Crapo and the President’s son in law Jerod Kushner in attempts to alert the President to my role as a SEC Whistle Blower and to assist him in a “counter inquiry” against the Democratic Party Impeachment Inquiry.

In that regard, on November 19<sup>th</sup> I emailed to Kushner a “Open Letter to President Trump” dated November 19, 2019 with exhibits and a fax cover describing the proposed “Counter Inquiry” strategy and the ongoing fake news media, including NBC Cover Up of Buffett’s failure to disclose a \$35 billion liability in his SEC filings. On November 21, 2019 I emailed the “Open Letter” to President Trump at his email address, and forwarded that email to Senator Mike Crapo who is Chairman of the Senate Banking Committee, with SEC oversight.

I have no idea if Mr. Kushner actually saw my email communication, but it was delivered to his email address. In Crapo’s case I did talk to his staff person who sends him emails directly to his attention. I was told my email was received and forwarded to him as evidenced by the reply of his staffer Courtney Lehosit at 12:44 pm on November 22<sup>nd</sup>. I printed that off from my inbox. Then at 8:56 pm a “Delivery Incomplete” appeared in my inbox. Luckily I had printed off Courtney’s reply shortly after it appeared in my inbox eight hours earlier. This is prove of “hacking” of my communications with the President and the United States Senator responsible for SEC oversight.

I have enclosed copies of both for your edification.

On December 4, 2019 I faxed this evidence and additional evidence of “hacking” of my emails to the President attaching a December 4<sup>th</sup> letter to Attorney General Willam Barr. This was done with assistance of the Assistant Manager Debra Damerst, at FedEx in Highlands Ranch, Colorado. (The December 4, 2019 letter to AG Barr is enclosed. In return I received a form letter. The AG did not see my fax and December 4, 2019 letter.

I also had a security problem at Fed Ex with my confidential SEC and FTC documents due to the “invasion” of FedEx in Highlands Ranch, Colorado by Carl Hill, and took the matter up directly with Fred Smith the CEO and founder. Smith is a fellow Viet Nam veteran and known to be helpful to veterans of the Viet Nam War. After a promising beginning things did not work out.

When I asked Smith’s Assistance (he is a well connected Republican) in reaching out to Republican Senators and President Trump to provide my SEC and FTC files for a “counter inquiry” and Attorney General Barr for the hacking conspiracy, I was pointedly told that it was not in Fed Ex’s interests to help me.

Later I found out that Smith is a very vocal critic of the President’s trade Policies, and especially with China, where Smith wants to market Fed Ex services. Smith is also a proponent of electric vehicles, and is Chairman of SAFE (Securing America’s Future Energy) a organization led by Smith and retired Generals and Admirals that is promoting wide spread use of electric vehicles to make America energy independent and not reliant on OPEC and the Middle East.. (President Trump accomplished that through increased energy production. The President is also negotiating peace in the Middle East).

I have enclosed some of my communications with Smith and responses from a FedEx Vice President and attorney.

Joe Biden is also a fan of electric vehicles, and reportedly has business dealing in China with his son Hunter Biden. Warren Buffett is also critical of the President’s China trade policies because he has an investment in a Chinese electric car company. If the “Green New Deal” was implemented by a Biden presidency the U.S. market for the Chinese electric cars Buffett is invested in would be enormous. Meanwhile, Biden and his son have business deals in China.

In fact, the very day that Biden announced his run for the presidency the Executive Vice President of Lobbying for Comcast, a big tech” company put on a \$21 million dinner for him. Comcast owns NBC whose CEO at the time was Stephen Burke who serves on Buffett’s Board of Directors.

Does this sound like the “old boys club” or the “swamp” the President is trying to drain?

By the way, after the hacking of my November 13, 2019 email attaching the November 12, 2019 Confidential letter to the President of the USA, and the hacking of my November 21, 2019 email attaching my November 19<sup>th</sup> “Open Letter” to the President describing my SEC Complaint V Buffett “et al” including Stephen Burke with a forward to Senator Mike Crapo Charman of the Senate Banking Committee, Burke announced on December 14<sup>th</sup> that he would retire when his contract expired on August 14, 2020. On January 1, 2020 Burke resigned as CEO of NBC remaining as Chairman until August 14, 2020. Burke was “on the top of his game” at NBC-Universal, and is only 61 years old.

On March 12, 2020 I sent a email string (enclosed) to Warren Buffett, “et al” containing a March 5,2020 email to the President, and a reference to the VA medical retaliation



against me on the last page for March 12<sup>th</sup>. The very next day Bill Gates resigned from Buffett's Board of Directors, and Microsoft's Board of Directors citing other commitments. I believe Buffett forwarded the email to Gates who shared it with his lawyers and hit the exit on advice of counsel. In May I confronted Gates and then Buffett in emails with my theory. NO RESPONSE. Gates knew everything that Burke knew, and I actually contacted Gates in April 2019 about his liability as a Board Member for Buffett and the non-disclosure of a \$35 billion asserted claim. I told Gates that he had two choices. Either force Buffett to correct the enormous disclosure omission, or resign from Buffett's Board. Otherwise I would name him in my next SEC Complaint for failure to correct the omission. Gates responded in a disingenuous letter from "Todd" a Microsoft Executive Response Center.

Gates problem and liability is enormous. The claim and omission is far greater than \$35 billion. If a civil rigo claim or anti-trust claim is upheld in federal court the damages are triple, or about \$100 billion. Now add in the fact that investors purchased about \$116 billion in Berkshire Hathaway without required disclosure of this huge contingent liability. These investors can demand rights of rescission and demand their money back. Now add in the investors who held their stock without required disclosure of this hugely material liability and can demand rights of rescission and your very likely talking about \$350 to \$400 billion.

Gate's net worth is about \$95 billion, and Buffett's is about \$82.5 billion. Shareholders can sue Board Members Buffett and Gates for Gross Negligence, and Violation of Fiduciary Duty. Get the picture?

Now add in the fact that some of the most prominent Democrats on the planet, with oversight responsibility protected Buffett, Gates and Burke, "et al" from Justice, and the news media, including NBC covered it all up.

Now add in two homicides, my father Otis L. Nelson Jr., a decorated WW!! Combat veteran and Polar Founder in August 2009, my fiancée Sharon Elizabeth Minnock in June 2013.

Now, add in that I provided extensive documentary evidence, and tried to get the FBI (as recommended to me by a FBI/Mueller investigator), and the Democrat Attorney General of Colorado to investigate those two homicides, and other crimes including bankruptcy fraud, cyber crime and threats of murder (RICO). Nothing happened.

Now add in two pending federal complaints with the FTC and SEC.

Now add in that the witness in those two federal complaints is a disabled combat veteran of the Viet Nam War and was targeted, and is still being targeted in a VA medical retaliation.

Now add in the fact that that witness/veteran tried to help the President of the United States Donald J. Trump as a Whistle Blower when the Democrats were launching a frivolous, partisan "impeachment inquiry" with one purpose and one purchase only, to

discredit the President of the United States and defeat him in the 2020 national elections, and defeat the Republican Senate majority as well, and take over the US government, and destroy the United States Constitutional Republic and replace it with a Marxist Oligarchy run by billionaires at the top.
